Shri Toli Kamdak is hereby temporarily engaged as Part Time Teacher (Art Education) under ISSE (Erstwhile SSA) purely on contractual and temporary basis in the fixed pay of Rs. 7000/- (Rupees Seven thousand) only against the vacant post of Miss Duter Bagra(PTT) under Tirbin block, Leparada district with immediate effect from the date of joining in the concern posting place against centrally sponsored scheme of ISSE(SSA) created against residential school. His appointment is purely on temporary and contractual basis.

He is posted at Govt. 100 Girls Residential School, Pira

The engagement is subjected to the following terms and conditions:

- w) The engagement is purely temporary basis and may be terminated at any time without assigning any reasons.
- x) The contract staff has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
