ORDER

Shri Tintong Borang is hereby engaged as J/T on contract basis in the fixed pay of Rs.8500/- (Rupees eight thousand five hundred) only with effect from the date of joining in the concerned school upto 31/03/2007 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He/she is posted at Govt. Sec. School, Borguli.

The engagement is subject to the following conditions :-

- a) The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- c) During contract service period he/she is not entitle for medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances etc.
- d) The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- e) He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of services.
- f) The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- g) No representation will be accepted for change of posting place.
- h) He/she will have to under gone DIET training at concern DIET for Training as and when call for.
- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.

The appointee shall be on probation for a period of 2 (two) years with effect from the date of issue of order. His/Her continuation beyond probation period for 2 (two) years shall be subject to satisfactory performance during probation period.

This issued with the Approval of Govt. Vide Note No. #139 Dated 19-07-2022.

The Appointment is subject to the following conditions:-

1. The salary will be drawn from the date of his/her joining in the duty.
2. The Appointment is purely temporary and may be terminated at any time by giving 1(one) month notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary.
3. The regularization of service will be considered on completion of probation period subject to satisfactory performance of duty.
4. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
5. The appointment is subject to Police verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
6. After joining duty he/she will have to take Oath of an allegiance of affirmation to the Constitution of India in the prescribed form.
7. On joining, the appointee shall have to serve for a minimum period of 3 (Three) years at the place of posting.
8. The seniority of the appointee shall be based strictly on their date of joining.
9. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15 (fifteen) days from the date of issue of this order at his/her posting place and copy of joining report be submitted to this Directorate through DDSE concerned.
10. On their appointment as Trained-Graduate Teacher (TGT) they should undergo compulsory in-service course of B.Ed. within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and condition of service which are not specified herein shall be governed by the rules in force from time to time.
