He/She is posted at NSCBAV, New Daring.

The engagement is subjected to the following terms and conditions:

- The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- No earned leave is permissible except casual leave/ML/CCL as per central civil service leave rule.
- During contract service period he /she is not entitled for medical reimbursement, winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances, etc.
- "No work No pay policy is enforced to the second party. In case of breach in discharging duty by the second party, the appointing authority is empowered to terminate him/her from contract service without prior information.
