Miss Jumbi Lombi is hereby appointed /engaged as TGT, Science (Secondary) purely on contractual basis in the fixed pay scale of Rs 25,000/- (Rupees Twenty Five Thousand) only against the resultant vacant post of Miss Gopi Riba, TGT, Science (Sec) under Basar Block, ISSE /Samagra Shiksha District Society, Leparada District with immediate effect from the date of joining in the concern posting place against centrally sponsored scheme of ISSE (SSA) approved against Secondary School, Leparada district.

He/She is posted at Govt Secondary School, Basar Bazar.

The engagement is subjected to the following terms and conditions:

- The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- No earned leave is permissible except casual leave/ML/CCL as per central civil service leave rule.
- During contract service period, he /she is not entitled for medical reimbursement, winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances, etc.
- "No work No pay policy is enforced to the second party. In case of breach in discharging duty by the second party, the appointing authority is empowered to terminate him/her from contract service without prior information.
- The contract appointee has to report his/her duty at posting place immediately within 7 days with the issue of this appointment order, failing which his/her appointment order will automatically be treated as cancelled.
- He /she is not entitle to subscribe GPF or CGEIS or such other schemes during the period of contract service.
- No representation will be accepted for change of posting place.
- The engagement order stand automatically cancelled with the expiry of the stipulated time, i.e 31st March and further extension shall be subject to satisfactory performance and extension of Project by MoE, Govt of India.
- The other terms and conditions of services which are not specified herein shall be governed by the relevant rules and orders in force under Samagra Shiksha/ISSE from time to time.
- The salary will be drawn as approved in the PAB of Erstwhile SSA from MHRD, GOI through SPD, Itanagar.
- The selected teacher has to sign "Deed of Agreement" for contract engagement/appointment before receiving this engagement/ appointment order copy.


