ORDER

In pursuance of Govt. approval vide U.O. No. 104 Dated 07.05.03 Shri Taken Bam is hereby appointed to officiate as AT(A) in-lieu of land donation to Education Department for establishment of Bam Middle School, Basar Circle, W/Siang District in the scale pay of Rs. 4500-125-7000/- per month plus other allowance as admissible under the Rules from time to time with effect from the date he/she actually reports for duty to the Dy. Director of School Education, West Siang District, Along. He is posted to Govt. Middle School, Bam, Basar Circle.

2. The appointment is made vice Shri Takar Dirchi, AT, retired.
3. The officer shall be on probation for a period of 2(two) years with effect from the date of joining. His/her continuation in service beyond probation period of two years to subject to satisfactory performance during probation period.
4. The appointment is subject to the following conditions :-
 - a) The appointment is purely temporary and may be terminated without any notice or assigning any reasons. If he/she wants to resign he/she may do so after giving one month's notice or by surrendering one month salary.
 - b) After joining duty he/she shall have to take an oath of allegiance of affirmation to the constitutions of India duly in prescribed form.
 - c) He/She will have to produce a medical fitness certificate in the prescribed form from an authorized Medical Officer.
 - d) The appointment is subject to the police verification and he/she will be dismissed from the Govt. service if any adverse reports are there with immediate effect.
 - e) The other terms and conditions of services which are not specified herein shall be governed by the relevant rules and order in force from time to time.
5. Shri Taken Bam shall have to continue for a minimum tenure of 3 (three) years terms in his present posting place.
