JT/AT(A) on contractual basis in the fixed pay of Rs. 26453/- (Rupees  
Twenty Six Thousand Four hundred and three only per month against the resultant vacancy of  
Shri/Miss Lido Komke, JT/AT(A) who resigned/expired/non joining  
from the post of JT/AT(A), under West siang District with effect from the date of joining in the  
concern place of the posting under SSA.

**The appointment is subject to the following conditions:-**

1. The contract Teacher has no rights to claim for regular appointment/regularization of the post after expiry of the contract engagement.
2. No earn leave is permissible except casual leave as per the central civil service leave rule and as per terms and conditions mentioned in the agreement copy.
3. During the contract service period he/she is not entitled for medical reimbursement, winter allowance, children education allowances, reimbursement of tuitions, fees, leave travel concession (LTC), special compulsory allowance etc.
4. The contractual teacher have no report his/her duty at posting place within 10 (ten) days from the date of joining the office of the concern DDSE-cum-DPO, failing which his/her engagement order will automatically be treated as cancelled.
5. He/she is not entitled to subscribe GPF of GIES or such other scheme during the period of contract service.
6. The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
7. No representation will be accepted for the change of posting place.
8. He/she will have to undergo DIET training at concern DIET for training as and when call for.
9. The other terms and conditions of the service which are not specified shall be governed by the relevant rules and order in force from time to time.
10. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.


