**ORDER.**

On the recommendation of Selection Board with pursuance of Govt. approval vide U.O. No. 179 Dated 03/08/2016, Smti. Jumpi Maro is hereby appointed temporarily as Primary Teacher in the pay scale of PB-2-9300-34800 + GP-4200/- per month plus other allowances as admissible under rules from time to time with effect from the date she actually reports for duties under disposal of DDSE, Longding, Longding District.

The appointment shall be on Person with Disability quota under 3% reservation in pursuance of Govt. of Arunachal Pradesh Office Memorandum No. OM -15/97 dated 14/07/1998 (amended from time to time). The appointment is made against the resultant vacancy of Lt. S.K. Tunnu, PRT, expired.

The appointment shall be on probation for a period of 2 (two) years w.e.f the date of joining. His/her continuation beyond probation period for 2 (two) years shall be subject to satisfactorily performance during probation period.

**The appointment is made subject to the following conditions:-**

1. The appointment is purely temporary and may be terminated at any time by giving 1 (one) month notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary.
2. The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
3. After joining duty he/she will have to produce Medical Fitness Certificate issued by Govt. recognized Medical Officer.
4. The appointment is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
5. After joining duty he/she will have to take oath an allegiance of affirmation to the Constitution of India in the prescribed form.
6. On joining, the appointee shall have to serve for a minimum period of 03 (three) years at the place of posting.
7. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 30 (thirty) days from the date of issue of this order at posting place.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
