- c) During contract service period he/she is not entitle for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowance etc.
- d) The contract teacher have to report his/her duty at posting place within 7(seven) days from the date of joining in the office of the concerned DDSE cum DPO, failing which his / her appointment order will automatically be treated as cancelled.
