The engagement is subject to the following conditions:-

- The contract employee has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- During contract service period he/she is not entitle for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC; special compensatory allowances etc.
- The employee shall be entitle for drawl of salary only against the working period every month.
- The contract employee shall have to report for duty at posting place within 7 (seven) days from the date of issue of order, failing which his/her appointment order will automatically be treated as cancelled. Salary will be drawn only from the date of joining in the office.
- He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- There shall be no provision for change of posting place.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and other in forced time to time.
- The appointed staff/officials have to sign an agreement for contract engagement before receiving this engagement order.


