ORDER

Shri Tarun Camdir Tok is hereby engaged as Primary Teacher (PRT) on contract basis in the fixed pay of ₹ 21,175.00 (Rupees Twenty One Thousands One Hundred Seventy Five) only with effect from 01/06/2017 to 31/03/2018 against centrally sponsored Scheme of SARVA SHIKSHA ABHIYAN. He/She is posted at Govt. Pry. School, Lower Tubang

The engagement has been made prior approval from state project Director, SSA Rajya Mission, Itanagar vide approval order No. AR/SSA/Inter-APTET-17/2017-18/ Dated Yupia the 18th Sept' 2018.

The engagement is subject to the following conditions:-

a) The contract Teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.

b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per

terms and conditions mentioned in the agreement copy.

c) During contract service period he/she is not entitled for medical reimbursement; winter allowance; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowance etc.

d) The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned Administrative Officer, failing which his/her engagement order will automatically be treated as cancelled.

e) He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract

f) No representation will be accepted for change of posting place.

g) He/She will have undergo DIET training at concerned DIET for training as and when call for

h) The validity of contract period is upto 31/03/2018 which may be extended by seeing the performance/regularity of teacher as recommended by concern SMC.

i) The other terms and conditions of service which are not specified shall be governed by the relevant rules and other in forced time to time.

j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.

k) The salary will be released only after receipt of fund from Govt. of India.
