**//ORDER//**

Shri Rikoo Zido is hereby temporarily engaged as Part Time Teacher (Physical Education) under ISSE (Erstwhile SSA) on purely contract and temporary basis in the fixed pay of Rs. 7000/- (Rupees Seven thousand) only against the vacant post of Shri Renge Bagra (PTT) under Basar block, Leparada district with effect from the date of joining in the concern posting place against centrally sponsored scheme of ISSE (SSA) created against residential school. His appointment is purely on temporary and contractual basis.

He is posted at Govt. 100 Girls Residential School, Daring.

**The engagement is subjected to the following terms and conditions:**

- a) The engagement is purely temporary basis and may be terminated at any time without assigning any reasons.
- b) The contract staff has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- c) No earned leave is permissible except casual leave as per central civil service leave rule.
- d) During contract service period he /she is not entitled for medical reimbursement, winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances, etc.
- e) The contract appointee has to report his/her duty at posting place immediately within 7 days with the issue of this appointment order, failing which his/her appointment order will automatically be treated as cancelled.
- f) He /she is not entitle to subscribe GPF or CGES or such other schemes during the period of contract service.
- g) No representation will be accepted for change of posting place.
- h) The engagement order stand automatically cancelled with the expiry of the stipulated time.
- i) The other terms and conditions of services which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
- j) The salary will be drawn as approved in the PAB of Erstwhile SSA from MHRD, GOI through SPD, Itanagar.
- k) The engaged staffs has to sign an agreement for contract engagement before receiving this engagement/ appointment order copy.
