During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel c) concession (LTC); Special compensatory allowance etc.

engagement order will automatically be treated as cancelled. He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of e)

The engaged teacher is also to work as volunteer instructor for PL Programme for the interest of the literacy in Arunachal Pradesh in addition his/her normal duties. f)

No representation will be accepted for change of posting place.

He/She will have under go DIET training at concerned DIET for training as and when call for. g)

The validity of contract period is upto 31/03/2009 which may be extended by seeing the h) performance/ regularity of teacher as recommended by concern V.E.C. i)
