The Appointment is subject to the following conditions:-

- 1. The salary will be drawn from the date of his/her joining in the duty. 2. The Appointment is purely temporary and may be terminated at any time by giving 1(one) month notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary.
- 3. The regularization of service will be considered on completion of probation period subject to satisfactory performance
