4. The appointee has to report his/her duty at concerned posting place within 7(seven) days from the date of issue of this appointment order, failing which his/her appointment order will automatically be treated as cancelled
5. He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
