Shri/Smti Ibom Riji, B.Sc II Yr. is appointed on ~~ad hoc~~/regular basis temporarily to officiate as A/T 'A' under the Directorate of Public Instruction, Govt. of Arunachal Pradesh and posted to B.S.B. Changlang in the scale of pay of Rs. 330 to 560 /- P.M. plus other allowances as admissible under the rules from time to time with effect from the date on which he/she reports for duty to the Dist. Education Officer/Principal/Headmaster, B.S.B. Changlang for Teachers Training.

2. (a) The appointment is subject to the following conditions :-  
The appointment is purely temporary and may be terminated at any time without assigning any reason after giving one month's notice from either side.
- (b) After joining duty he will have to take an oath of allegiance or give affirmation to the Constitution of India duly in the prescribed form before an officer.
- (c) He will have to produce a Medical certificate from an authorised medical officer to the effect that He/she is medically fit for the government service.

The appointment is subject to the police verification and he/she will be discharged from service with immediate effect if there be any adverse remarks against him/her in the police report.

The other terms and conditions which are not specified herein would be governed by the rules and order that may be in force from time to time.
