ORDER

The appointment shall be on Compassionate Ground as Govt. of India, ministry of home Affairs Order No. 1404/20/90 Estt. (D) dated 09/12/93

The appointment is made against the vacant post of Shri Som Dorjee Kharna PRT (Promoted)

The Appointment is made subject to the following conditions:-

1. After joining duty he / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
2. The Appointment is subject to Police verification and he / she will be dismissed from service if any adverse report is found against him / her with immediate effect.
3. After joining, duty he/she will have to take Oath of an allegiance of affirmation to the constitution of India in the prescribe form.
4. On joining, the appointee shall have to serve for minimum period of 3 (three) years at the place of posting.
5. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15 (fifteen) days from the date issue of this order at posting place

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force time to time.
