The appointment shall be on probation for a period of 2 (two) years with effect from the date of issue of order. His/ her continuation beyond probation period for 2 (two) years shall be subject to satisfactory performance during probation period.

**The appointment is subject to the following conditions: -**

1. The salary will be prepared from the date of his/ her joining in the duty.
2. The appointment/ regularization is purely temporarily and may be terminated at any time by giving 1 (one) month notice in case if any given or information furnished by the teacher proves to be false and if the teacher is found to have willfully suppressed any material fact, he/ she will be liable to be removed from service/ discharged from probation and such other action may be taken by the Govt. as deem fit.
3. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary
4. The regularization of service will be considered on completion of probationary period subject to satisfactory performance of duty.
5. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer
6. The appointment is subject to Police verification and he/ she will be dismissed from service if any adverse report is found against him/ her with immediate effect.
