ORDER

In pursuance of Govt. approval Sri. Kabit Gette is hereby appointed temporarily as Primary Teacher (PRT) in the pay Matrix-Level-6. Cell-1 of Rs.35400/-per month plus other allowances as admissible under the rules from time to time with effect from the date he/ she actually reports for duties. He / She is posted at the disposal of Principal, GHSS, Pessing District.

The appointment is made against the vacant post of Sri C.K. Sudha, PRT, retired.

The appointment shall be on probation period for a period of 02 (two) years w.e.f. the date of joining. His / her continuation beyond probation period for 2 (two) years shall be subject to satisfactorily performance during probation period.

The appointment is made subject to the following conditions :-

- a) After joining duty he/she will have to take an oath allegiance or give affirmation to the Constitution of India duly in the prescribed form.
- b) He / She will have produce medical certificate from the authorized Medical Officer to the effect that he/ she is medically fit for Govt. service.
- c) The appointment is subject to police verification and he/she will be dismissed from the service with immediate effect if there adverse remarks against him/her in Police verification.
- d) On joining, the appointee shall have to serve for a minimum period of 03 (three) years at the place of posting.
- e) The confirmation of service will be considered on completion of probationary period subject to satisfactorily performance of duty.
- f) The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place, from the date of issue this order.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
