

## // APPOINTMENT ORDER //

Shri/Smt. JEENU NAMCHOM is hereby engaged as Upper Pry. Teacher (TGT) Science/Mathematics/Social Science/Language (English/Hindi) on contract basis in the fixed pay of 26,453.00/- (Rupees Twenty Six thousand four hundred fifty three) only with effect from 1st - June - 2017. In the Namsai district up to one year against centrally sponsored scheme of SARVA SIKSHA ABHIYAN. He/ She is posted at Govt. Upper Primary School, Mengkeug - Misi.

**The Engagement is subject to the following conditions:-**

1. The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
2. No earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and conditions mentioned in the agreement copy.
3. During contract service period he/she is not entitled for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.
4. The contract teacher have to report his/her duty at posting within 7(seven) days from the date of joining in the concerned DDSE's office failing which his/her engagement order will automatically be treated as cancelled.
5. He she is not entitled to subscribe GPF/CGEIS or such other schemes during the period of contract services.
6. The engaged teacher is also to work as volunteer instructor of TLC/PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./Dist. Administrator/Education Department in any addition to his/her normal duties.
7. No representation will be accepted for change of posting place.
8. The other terms and conditions of service which are not specified shall be governed by the relevant rules/orders/guidelines/instruction in force time to time.
9. The engaged teacher has to sign an agreement for contract agreement before receiving this engagement order.
10. His/ Her contractual service will remain valid for 1 (one) year and thereafter it will be treated automatically terminated and a fresh renewal will be required.


