In the interest of the public service, Miss Kaidin Bisen is hereby appointed provisionally to officiate as Assistant Teacher Grade 'A' in the Scale of Pay Rs. 4500-125-7000/- p.m. plus other allowances as admissible from time to time w.e.f. the date she actually reports for duty at her posting place, Rajanagar III Primary School, Ordumsa Circle.

This appointment is subject to the approval of the Director of School Education, A.P., Naharlagun and on the following terms and conditions:-

- (i) The appointment is purely temporary and may be terminated at any time without assigning any reason after serving one month notice. If she wants to resign may require to give one month notice or surrender one month salary,
- (ii) She will have to produce Medical Fitness Certificate in prescribed form issued by not below the rank of DMO/CMO/Civil Surgeon and should be submitted in her posting place alongwith joining report.
- (iii) Joining will be accepted from the date she actually reports for duty in her posting place.
- (iv) After joining in duty she shall have to take Oath of allegiance of affirmation to the constitution of India in the prescribed form.
- (v) The appointment is subject to police verification and she will be dismissed from Govt. service if any adverse report is there with immediate effect.
- (vi) The First 2 (two) years of her service will be treated as probationary period.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.

The expenditure is debitable to the Head of Account '2202' Education.

This appointment is made in a vacant post of Shri Mose Umpe AT(A) who was promoted to Junior Teacher.
