- 1. The contractual appointment has no right to claim for regular appointment/regularization of the post after expiry of contract period.
- 2. No earned leave is permissible except casual leave as per Central Civil Service leave rule and as per terms and condition mentioned in the agreement copy.
- 3. During contract service period he/she is not entitle for medical reimbursement, winter allowances (LTC), special compensatory allowance except fixed pay of Rs. 5000/- Per month.
- 4. The appointee has to report his/her duty at concerned posting place within 7(seven) days from the date of issue of this appointment order, failing which his/her appointment order will automatically be treated as cancelled.
- 5. He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract
