She is appointed in place of sh. Kenge Bagra and posted at Govt. Residential School Papikrung.

The appointment is made subject to the following terms and conditions:-

1. The engagement is a purely temporary basis and may be terminated from service anytime without assigning any causes/notice considering his/her performance of service.

2. The contractual appointment has no right to claim for regular appointment/regularization of the post after expiry of contractual period.

No earned leave is permissible except casual live as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.

4. During contract service period he/she is not entitle for medical reimbursement, winter allowances (LTC), special compensatory allowance except fixed pay of Rs. 5000/ per

The appointee has to report his/her duty at concerned posting place within 7(seven) days from the date of issue of this appointment order, failing which his/her appointment order will automatically be treated as canceled.

6. He/she is not entitled to subscribe GPF or CGEIS or such other schemes during the

period of contact services.

No representation will be accepted for change of posting place. The other terms and condition of service which are not specified here in shall be govern by the relevant rules and order in forced from time to time.
