on contract basis under SSA in the fixed pay of Rs. 8500/- (Rupees Eight thousand
Five hundred only with effect from the date of joining in the concern
district for a period of 1 (One) year. He / She is posted at Govt. Sec-School, Kabilma
against resigned post of Shri/Smti./Miss. vacant post.

The engagement is subjected to the following conditions:-

- 1) The contract Teacher has not right to claim for regular appointment / regularization of the post after expiry of contract appointment.
- 2) No earned leave is permissible except casual leave as per Central Civil Service leave Rule as per terms and condition mentioned in the agreement copy.
- 3) During contract service period he / she is not entitle for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition on fees, leave travel concession (LTC), special compensatory allowances etc.
- 4) The contract Teacher have to report his / her duty at posting place within 7 (seven) days from the date of issue of this order for joining in the concerned DDSE failing which his / her engagement order will automatically be treated as cancelled.
- 5) He / she is not entitle to subscribed GPF or CGEIS or such other schemes during the period of contract services.
- 6) The engaged teacher is also to work as volunteer instructor for TLC Programme for the interest of literacy in Arunachal Pradesh in addition to his / her normal duties.
- 7) No representation will be accepted for change of posting place.
- 8) He / she will have to under gone DIET training at Naharlagun/Yachuli when call for DIET training at Naharlagun/Yachuli.
- 9) The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in force time to time.
- 10) The engaged teacher has to sign and agreement for contract engagement before receiving this appointment order.


