ORDER.

with pursuance of the Govt. approval vide U.O. No. 201 dated 07/07/2016, Miss. Kaku Litin is hereby appointed temporarily as Primary Teacher in the pay scale of PB-2-9300-34800 + GP-4200/- per month plus other allowances as admissible under rules from time to time with effect of the date he / she actually reports for duty at disposal of DDSE, Roing, Lower Dibang Valley District.

The appointment shall be on compassionate ground as Govt. of India, Ministry of Home Affairs Order No. 1404/20/90 Estt. (D) dated 09/12/93. The appointment is made against the resultant vacancy of Smti. Sashi Sharma, Primary Teacher, retired.

The appointment is made subject to the following conditions:-

1. The appointment shall be on probation for a period of 3 (three) years. During probationary period, his /her service may be terminated at any time without giving any notice or assigning any reason. The regularization of service will be considered on completion of probationary period subject to satisfactory performance of duty during probation period.
2. After joining duty he/she will have to produce Medical Fitness Certificate issued by Govt. recognized Medical Officer.
3. The appointment is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
4. After joining duty he/she will have to take oath an allegiance of affirmation to the Constitution of India in the prescribed form.
5. On joining, the appointee shall have to serve for a minimum period of 03 (three) years at the place of posting.
6. The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 30 (thirty) days from the date of issue of this order at posting place.
7. On his / her appointment as Primary Teacher he / she should undergo compulsory in-service DPE/ D.El.Ed./ B.Ed. within three years failing which his / her appointment order shall be cancelled.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
