## 3. The appointment is subject to the following conditions:-

(a) The appointment is purely temporary and may be terminated with 1(one) month notice. If he/she wants to resign he/she may do so after giving I (one) month notice or by surrendering I (one) month's salary.

(b) The confirmation of service will be considered on completion of probationary period subject to satisfactory

(c) After joining duty he/she will have to take an oath of allegiance of affirmation to the Constitution of India in the

(d) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.

(e) The appointment is subject to the Police Verification and he/she will be dismissed from Govt. service if there is any adverse report against him/her..

(f) On joining, the appointee shall have to serve for a minimum of 2(two) years at the place of posting.

(g) The seniority of the appointee will be based strictly on merit list in which he/she had been selected for appointment on contract basis.

(h) The appointee will not have any claim whatsoever for the services rendered by him or her as a JT Hindi (Contract) from the date of their initial appointment till the date of regularization i.e. 01.05.2007. Their regularizations is effected from 1st May'2007.
