- b) After joining duty he/she will have to take an oath of allegiance or give affirmation to the Constitution of India duly in the prescribed form.
- c) He/She will have to produce a Medical Certificate from an authorised Medical Officer to the effect that he/she is medically fit for the Govt. service.

The Appointment is subject to the Police verification and he/she will be discharged from service with immediate effect if there be any adverse remarks against him/her in the Police Report.

The Other terms and conditions which are not specified here would be governed by the rule and order that may be in force time to time.


