- (d) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- (e) The appointment is subject to the Police Verification and he/she will be dismissed from Govt. service if there is any adverse report against him/her..
- (f) On joining, the appointee shall have to serve for a minimum of 2(two) years at the place of posting.
- (g) The seniority of the appointee will be based strictly on merit list in which he/she had been selected for appointment on contract basis.
- (h) The appointee will not have any claim whatsoever for the services rendered by him or her as a JT Hindi (Contract) from the date of their initial appointment till the date of regularization i.e. 01.05.2007. Their regularizations is effected from 1<sup>st</sup> May'2007.

2. His/ Her continuation in the post is subject to satisfactory performance during probation

for a period of 2 (two) years from the date of joining in the posted school.

3. The promotee carries with the liabilities to serve in any Govt. Higher Secondary School of Arunachal Pradesh.

4. The promotee shall join the school within 15 (fifteen) days failing which his/ her promotion order shall automatically stand cancelled.

5. No representation regarding change of place of posting will be entertained in any circumstances.

6. The other terms and conditions which are not specified herein shall be governed as per existing Government Rules and Orders in force from time to time.

7. Refer earlier transfer order: The Head of the Institutions are requested to release the transferred teachers against whom reliever is posted on promotion.
