//ORDER//

Miss Esther Godak , D/O -Sri Godak Taja is hereby appointed as assistant teacher(A/T) on contractual basis for a period of one year under ISSE programme of Kamle District in the fixed scale of pay of Rs.27901/- (Twenty Seven Thousand Nine Hundred One)only per month with effect from the date of joining in the place of posting. He/She is posted to Govt. Middle School, Kamporijo against the resultant vacancy created due to resignation of Sri Melee Anvey Tajum, A/T( SSA).

The contractual appointment is subjected to the following conditions :-

1. The contractual appointee shall not have right to claim for regularization /regular appointment of the post after expiry of the contractual appointment.
2. The contractual appointee shall have to sign an agreement for contract engagement pertaining to the norms & rules governing the services of the appointee before receiving his/her appointment order.
3. No earned leave shall be permissible except casual leave as per Central Civil Services(CCS) Leave Rules in accordance with the condition mentioned in the deed of agreement .
4. During contractual service period, the appointee shall not be entitled for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fee, leave travel concession(LTC), special compensatory allowance etc.
5. The contractual appointee shall have to report for the duty at his/her place of posting within 07 (Seven) days from the date of issue of this order for joining under the concerned DPO failing which his/ her order of contractual appointment shall automatically be treated as cancelled.
6. The appointee shall have also to serve as volunteer Instructor for TLC programme to enhance the literacy rate in Arunachal Pradesh in addition to his/her normal duties.
7. The appointee shall not be entitled to subscribe in GPF or CGI&S or such other schemes during the period of contractual service.
8. No representation shall be accepted for the change in place of posting.
9. The appointee shall have to undergo to attend Induction Training Programme for a period of 30 days as and when such programme is scheduled during the contractual period.
10. The other terms & conditions of contractual services which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
