




VERIFICATION REPORT OF THE FIRE ACCIDENT OF DATED 19-05-2018
AT RUMGONG, SIANG DISTRICT, ARUNACHAL PRADESH

After receiving a written information from Shri Taben Gao, a resident of Rumgong township regarding fire accident which took place on 19-05-2018 at around 05:30 pm. A board with following members was duly constituted vide order No.RMG/DM/2018 Dtd. 19-05-2018 to verify the place of occurrence of fire accident.

Accordingly, the board members have verified the spot/place of occurrence and found that the dwelling house of the victim ~~was~~ completely gutted down into ashes and nothing could be recovered from the fire mishap. As per the information taken from the victim's family and neighbours, the actual caused of the fire is not ascertained and assumed that fire accident might have occurred from the remains of the extinguished fire after using it for cooking. During the verification it was also found that the devastated fire have caused extensive loss of the properties of the house owner. After detail verification and as per the statement taken from the house owner along with the residue of the burnt materials as evidence, the following loss items are listed below at annexure 'A' with approximate valuation.




