The appointment shall be on probation for a period of 2 (Two) years w.e.f. the date of joining. His/her continuation beyond probation period for 2 (two) years shall be subjected to satisfactory performance during probation period.

## The Appointment is subjected to the following conditions:-

- 1. The appointment is purely temporary and may be terminated at any time by giving 1 (one) month notice. If he/she wants to resign, he/she may do so after giving on month notice or by surrendering on month salary.
- 2. The regularization of service will be considered on completion of probationary period subjected to satisfactory performance of duty.
- 3. After joining duty he/she will have to produce Medical Fitness Certificate from an
- 4. The appointment is subjected to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.
- 5. After joining duty he/she will have to take Oath an allegiance of affirmation to the Constitution of India in the prescribed form.
