APPOINTMENT ORDER

- 10. The engaged teacher is also to work volunteer instructor for TLC programmes for the interest of literacy in Arunachal Pradesh in addition to the normal duties.
- 11. No representation will be accepted for change of posting place.
- 12. He/She will have to under go DIET training at concern DIET for training as and when call for.
- 13. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- 14. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced from time to time as per Central Civil Services (Temporary Services) Rules 1965.
