i. He / she will have to under gone DIET training at concern DIET for Training as and when call for.

j. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.

k. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
