b) No carned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.

c) During contract service period, he/she is not entitle for medical reimbursement, winter allowances, children education allowances, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowances etc.

f) He/She is not entitled to subscribed GPF or COEIS or such other schemes during the period of contract services.

g) No representation will be accepted for change of posting place, h) He/She will have to undergo for training as and when call for.

i) The other terms and conditions of services which are not specified herein shall be governed by the relevant rules and order in forced time to time.

j) The engaged employee has to sign at agreement and affidavit for contract engagement before receiving this engagement order.
