APPOINTMENT ORDER

The engagement is subject to the following conditions:-

- The contract employee has no right to claim for regular appointment/regularization of the post after expiry of contract engagement
- No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
- During contract service period he/she is not entitled for medical re-imburement; winter allowance; children education allowance; re-imburement of tuition fees; leave travel concession(LTC); Special compensatory allowance etc.
- The Second party shall be entitled for drawl of salary of only for the contract period of one year; salanes for vacation period shall be drawn only when they are engaged departmentally, but subject to availability o fund and approval of the competent authority.
