ORDER

Sri Pedam Nyokir is hereby engaged as Information and Communication Technology (ICT) Instructor (Secondary) and posted to Govt. Sec. School Liru, under the establishment of District Project Officer, Samagra Shiksha Society (ISSE), Lower Siang District on contract basis till 31st March'2024 in the consolidated pay of Rs. **15000/- (Rupees Fifteen Thousand)** only per month with effect from the date of joining in the place of posting.

The engagement is made vide our advertisement no LSD/SSE/ICT/2021-22/6827, Dated 22nd June'2023. The engagement is subject to the following conditions:

1. The contract appointee has no right to claim for regular appointment/regularization of the post after expiry of contract agreement
2. No earned leave is permissible.
3. During contract service period, he/she is not entitled for medical reimbursement, leave concession (LTC), Special Compensatory allowances, etc.
4. The appointee shall be entitled for drawl of salary as approved by the State Project Director, Samagra Shiksha Society/ISSE, Govt. of AP. Itanagar.
5. "No work no pay" policy is enforced to the appointee in case of breach in discharging duty by the appointee. The appointing authority DC-cum-DPD, ISSE is empowered to terminate him/her from contract service without prior information.
6. The contract appointee is engaged till 31st March 2024.
7. Re-engagement/continuation of the service shall be subject to availability of funds and his/her satisfactory performance while on duty and extension of the project by MoE, Govt. of India.
8. The contract appointee has to report for his/her duty at posting place within 7(Seven) days, failing which his/her appointment order will automatically be treated as cancelled.
9. Discontinuation of ISSE Scheme by MoE Govt. India will automatically lead to discontinuation of contract service of the incumbent.


