- (vii) He / she shall remain in the place of posting for minimum period of 3 (three) years from the date of joining. No representation / no campaigning for the change of posting place shall be entertained before completion of minimum 3 (three) years of service.

Other terms & conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
