He/she is posted at 100 girls Residential School Gensi.

The appointment is made subject to the following terms and conditions:-

- 1. The contractual appointment has no right to claim for regular appointment/regularization of the post after expiry of contractual period.
- No earned leave is permissible except casual live as per central civil service leave rule and as per terms and condition mentioned in the agreement copy
- 3. During contract service period he/she is not entitle for medical reimbursement, winter allowances (LTC), special compensatory allowance except fixed pay of Rs5000/- per month.
- The appointee has to report his/her duty at concerned posting place within 7(seven) days from the date of issue of this appointment order, failing which his/her appointment order will
- automatically be treated as canceled 5. He/she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contact services.
- 6. No representation will be accepted for change of posting place.
- The other terms and condition of service which are not specified here in shall be govern by the relevant rules and order in forced from time to time.
- The appointee on contract basis has to sign an agreement for contractual appointment at the time of receiving his/her appointment order copy.
