APPOINTMENT ORDER

Miss Ngasa Ronya PRT(ISSE), is hereby engaged as Primary Teacher (PRT) on contract basis in the fixed pay of Rs. 15,000/- (Rupees Fifteen Thousand) only with effect from the date of joining in the concerned school up to 31/03/2023 against Centrally sponsored scheme of Samagra Shiksha , ISSE. He/She is posted at Govt. School, ~~Sachin~~ ~~Chang~~ under Daporijo Education Block of Upper Subansiri District.

The engagement is made against the Advertisement Vide No. EDN/US/ISSE-INTERVIEW/ISSE-II/2020-21, Dated Daporijo the 22nd March/2022. & result Notification dated 26th May/2022.

This order issue as per administrative approval of the competent authority of Samagra Shiksha ISSE, Arunachal Pradesh, Itanagar Vide Order No. SS/11030/0/2022, Dated Itanagar 13th June/2022.

The engagement is subject to the following conditions :-

1. The contract teachers has no right to claim for regular appointment /regularization of the post after expiry of contract engagement.
2. No Earned leave is permissible except casual leave as per central Civil Service Rule and as per terms and conditions mentioned in the agreement copy.
3. During contract service period he/she is not entitled for medical reimbursement , winter allowance , children education allowance, reimbursement of tuition fees, leave travel concession (LTC), special compensatory allowance etc.
4. The contract teachers have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned Administrative officer , failing which his/her engagement order will automatically be treated as cancelled.
5. He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.
6. No representation will be accepted for change of posting place.
7. He/She will have to undergo for DIET training at concerned DIET as and when call for.
8. The validity of contract period is upto 31/03/2023 which may be extended by seeing the performance/regular of teacher as recommended by concern SMC.
9. The other terms and conditions of service which are not specified shall be governed by the relevant rules or other in forced time to time.
10. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.


