ORDER

In Pursuance of Govt. Approval Vide U .O .No. Nil dated 20th December' 2015, Miss Ainam Megu is hereby appointed temporarily as Primary Teacher (PRT) in the Pay Matrix Level-6, Cell-I Per month plus other allowance as admissible under the rules from time to time with effect of the date he / she actually reports for duty at Govt. Hr. Sec. School Mebo , East Siang District.

The appointment is made against the resultant vacancy of Sri A.R Prasad, PRT Retired.

The appointment shall be on probation for a period of 2 (two) years with effect from the date of joining. His/Her continuation beyond probation period for 2 (two) years shall be subject to satisfactory performance during period.

The appointment is made subject to the following condition :-

1. The Appointment is purely temporary and may be terminated at any time by giving 1 (one) month notice. If he/she wants to resign , he/she may do so after giving one month notice or by surrendering one month salary .
2. The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
3. After joining duty he/she will have to produce Medical Fitness Certificate issued by Govt. recognized Medical Board.
4. The appointment is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him /her with immediate effect.
5. After joining duty he/she will have to take Oath of an allegiance of affirmation to the constitution of india in the prescribed form.
6. On joining , the appointee shall have to serve for a minimum period of 05 (Five) years at the place of posting.
7. The seniority of the appointee shall be based strictly on their on merit list.
8. The appointment order shall be cancelled if the appointee directly or indirectly campaign for charge of posting place or does not join within 30 (thirty) days from the date of issue of this order posting place.

The other terms and condition of service which are not specified here in shall be governed by the rules in force from time to time.
