c) During contract service period he/she is not entitle for medical reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowance etc.

d) The contract teacher have to report his/her duty at posting place within 7(seven) days from the date of joining in the office of the concerned DDSE cum DPO, failing which

his / her appointment order will automatically be treated as cancelled.

e) He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.

f) The appointed teacher is also to work as volunteer instructor for TLC programmed for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.

g) No representation will be accepted for change of posting place.

h) He/She will have to under gone DIET training at concern DIET for Training and when
