O R D E R

Miss Mannam Arangham is hereby engaged as **ICT, Instructor (Secondary Level)** purely on contract basis in the fixed pay of **Rs. 15,000/- (Rupees Fifteen Thousand)** only per month with effect from the date of joining in the School and she is posted at Govt. Hr. Sec. School, Longding under Longding Circle of Longding District, Longding (AP).

The engagement is made subject to the following terms and conditions: -

1. This engagement is made in pursuance to the Administrative approval of SPD, Samagra Shiksha/ISSE, Itanagar vide file No. SS-20/4/2023-O/o SPD-SAMAGRA SHIKSHA, Dated the 12th Sept'2023.
2. The Contract ICT, Instructor has no right to claim for regular appointment/regularization of the post after expiry of contract engagement. The engagement is made till 31st March'2024. However, they can be re-employed subject to satisfactory performance of duty and allocation of funds under ICT recurring cost in the subsequent year by the MoE, Department of School Education and Literacy, GOI.
3. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
4. If the incumbent remains absent, no Pay will be paid for the absent periods under "No work No pay".
5. In case, he/she is found not staying in his/her place of posting and not sincere in his/her duty, her Contract Service will be terminated at any time by the Samagra Shiksha/ISSE District Society.
6. At the end of the contract Agreement, the incumbent shall have to again enter into fresh contract for the next academic period subject to continuation of his/her service or satisfactory of the performance.
7. During contract service period he/she is not entitle for Medical Reimbursement, Winter Allowance, Children Educational Allowance, Reimbursement of Tuition Fees, Leave Travel Concession (LTC), Special Compensatory Allowance etc.
8. The Second Party shall be entitled for drawal of salary of only for the academic session.
9. The contract teacher has to report his/her duty at posting place within 7 (seven) days from the date of issue of this order, failing which her engagement order will automatically be treated as cancelled.
10. He/she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contract services.
11. The engaged ICT, Instructor is also to work volunteer instructor for TLC programmes for the interest of literacy in Arunachal Pradesh in addition to the normal duties.
12. No representation will be accepted for change of posting place. The post is non-transferable in nature and engagement is made against designated schools only. No representation for quarters/accommodation shall be entertained in the posting place.
13. The new appointees shall be mandatory to undergo an induction training and orientation programmes by the state office after his/her engagement.
14. The engaged ICT, Instructor has to sign an agreement for contract engagement before receiving this engagement order with 1 (one) day break in service every after 2 (two) months or 60 days shall be incorporate in the deed of agreement.
15. The other terms and conditions of services which are not specified shall be governed by the relevant rules and order enforced time to time as per Central Civil Services (Temporary Services) Rules 1965.


