concerned district upto 2016-17 against centrally sponsored scheme of Sarva Shiksha Achyan He/
posted at Primary/ Upper Primary School Govt. Girls Res. School Mopom.

The engagement is subjected to the following conditions:-

- a) The contract teacher has no right to claim for regular appointment after the expiry of the post after such contract engagement.
- b) No Earn Leave is permissible except casual leave as per Central Govt. Rules and as per terms condition mentioned in the agreement copy.
- c) During the contract service period he/ she is not entitle for Medical facilities, pension, gratuity, educational allowances; reimbursement of tuition fees; leave travel concession (LTC) special concessional allowances etc.
- d) The second party shall be entitling for drawl salary of only for the academic session. Salaries for vacation or shall be drawn only when they are engaged in Training, Bridge Course and other responsibilities engagement.
- e) The contract teacher have to report his/ her duty at posting place within 10 days from the date on joined the office of the concerned DDSE, failing which his/ her engagement order will be annulled on 10th day of contract.
- f) He /she is not entitle to subscribe GPF for CGI IS or such other scheme during the period of contract service.
- g) The engaged teacher is also to work as volunteer instructor for TLC, pro- active for the interest of States Arunachal Pradesh in additional to his/ her normal duties
- h) No representation will be accepted for change of posting place.
- i) He/ she will have to undergone DIET Training at concerned DIET for training up and when call for
- j) The other terms and condition of services which are not specified shall be governed by the applicable rules and in forced time to time.
- k) The engaged teacher has to sign an Agreement for contract engagement before receiving the engagement order
