REGISTRATION OF CONTRACT ENGAGEMENT FORMS OF THE STATE EDUCATION DEPARTMENT

On the basis of recommendation of Saranga District Board and administrative approval granted to the state project scheme, Saranga District Board Order No. 10,1001/1/2021 dated 10/10/2021.

Mr. [Name] (Saranga District Board) is hereby engaged as PRT, on contractual basis in the post of Mr. [Name] (Saranga District Board) with effect from the date of joining at the Post of Posting date 10/10/2021 under the centrally sponsored scheme of Integrated Scheme for School Education (ISSSE) and he is posted at [School Name] Saranga District Board, Saranga District, Andhra Pradesh.

- The contractual engagement is subject to following terms and conditions:
- The engaged PRT, has no right to claim for regular appointment/regularization of the post after expiry of contractual engagement period.
 - The engaged teacher permissible except casual leave as per the revised Cut Service Rules and as per terms and conditions mentioned in the agreement copy.
 - If the incumbent remains absent, he/she will be paid for the absent period.
 - In case, the appointment is found not staying in his/her post of posting and not attending his/her duty, his/her contractual appointment will be terminated at any time by the State Education Authority.
 - At the end of the agreement, the incumbent shall have to appear and give final report for the post assigned period.
 - During the contractual service period he/she is not eligible for medical reimbursement, Winter Allowance, Children Education Allowance, Reimbursement of Tuition Fees, Leave Travel Allowance, Special Compensatory Allowance etc.
 - The Contract PRT, have to report his/her duty of posting place within 7 (seven) days from date of joining in the office of the concerned DSD, failing his/her engagement order will automatically be treated as cancelled.
 - He/she is not entitled to receive GP, CILIS or such order scheme during the period of contract services.
 - No representation shall be accepted for change of posting place.
 - He/she will have to undergo and Induction Training and Orientation Programs organize by the DPO Office as and when call for.
 - The engaged PRT has to sign an agreement for contract engagement.
 - The above terms & condition which are not specified herein shall be governed by the relevant rules and orders in force issued by the Saranga District Board Annual/Pradesh from time to time.
