APPOINTMENT ORDER

On the basis of recommendation of interview Board and administrative approval accorded by the state project director, Samagra Shiksha (ISSE) vides Order No. 55-11011/2022-O/o-SPD-SS/169833/2023, DATED 26th September'2023.

Miss Nanu Kabak D/O Lt. Shalla Kabakis hereby engaged as Part Time Teacher (NSCBAV) on Contractual basis in fixed pay of Rs.10000/- (Rupees Ten Thousand) only per month with effect from the date of joining in the Place of Posting upto 31st March'2024 under the centrally sponsored Scheme of Integrated Scheme for School Education (ISSE) and He is posted at Govt. NCBAV School Aye under Raga Block against the resultant vacancy Shri. Kabak Kissan who has resigned from the post of PTT against Govt. NSCBAV Aye.

The contractual engagement is Subject to following terms and condition:-

1. The contract PPT(NSCBAV) has no right to claim for regular appointment/regularization of the post after expiry of contractual engagement period.
2. No earned leaves permissible except Casual leave as per the central Civil Service leave rule and as per terms and the condition mention in the agreement copy.
3. If the incumbent remain absent, no pay will be paid for the absent period.
4. In case, the appointee is found not staying in his/her place of posting and not sincere in his/her duty, his/her contractual service will be terminated at any time by the ISSE Director/ authority.
5. At the end of the agreement, the incumbent shall have to again enter into fresh contract for the next academic period.
6. During the contractual Service period he/she is not entitle for medical reimbursement, Winter Allowances, Children Education Allowances, Reimbursement of Tuition Fees, Leave Travel Concession , Special Compensatory Allowance etc.;
7. The Contract Part Time Teacher(NSCBAV) have to report his/her duty at posting place within 7 (seven) Days from date of joining in the office of the concerned DDSE, failing his/her engagement order will automatically be treated as cancelled.
8. He/she is not entitled to subscribe GPF, CGEIS or such order scheme during the period of contract services.
9. No representation shall be accepted for change of posting places.
10. He/she will have to undergo and Induction Training and Orientation Programs organize by the SPD Office as and when call for.
11. The engaged Part Time Teacher(NSCBAV) has to sign an agreement for contract engagement.
12. The other terms & condition which are not specified herein shall be governed by the relevant rules and orders in force issued by the Samagra Shiksha/ISSE Arunachal Pradesh from time to time.
