ORDER

In pursuance of Govt. approval vide U.O. No. 304 dated 17/1/05 Smti. Elizabeth Majumdar is hereby appointed temporarily to officiate as Assistant Teacher (A) in the scale of pay of Rs. 4500-125-7000/- P.M. plus other allowances as admissible under rules from time to time w.e.f. he actually reports for duty at Govt. Middle School, Lal Bahadur Shastri under the disposal of DDSE Pasighat, District East Siang, Arunachal Pradesh.

2. The appointment is made vice Shri. Agom Taying, AT(A) (Rtd.).

3. The appointment shall be on probation for a period of 2(two) years w.e.f. the date of joining. Her continuation in services beyond probation period of 2(two) years is subject to satisfactory performance during probation period.

3. The appointment is subject to the following conditions:-

- a) The appointment is purely temporary and may be terminated with 1(one) month notice. If she want to resign he may do so after giving 1(one) month's notice or by surrendering 1(one) month salary.
- b) The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
- c) After joining duty she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- d) She will have to produce Medical fitness Certificate from an authorized Medical Officer.
- e) The appointment is subject to the Police Verification and he will be dismissed form Govt. service if there is any adverse report from the Police.
- f) On joining the appointee shall have to serve for a minimum of five years at the place of posting.
- g) The appointment order shall be cancelled, if the appointee directly or in-directly campaigns for change of place of posting or does not join within 10(ten) days from the date of issue of this order

Other terms and conditions of service, which are not Specified herein shall be governed by the relevant rules and order in force from time to time.


