ORDER NO- 19

On the recommendation of the Departmental Promotion Committee (DPC 22-23) held on 19th May'2023 Shri **Riatwang Ngowa, PRT**, his promotion was kept under condition of "subject to submission of Vigilance Clearance Certificate" (VCC) and subsequently on issuance of VCC by the State Vigilance Department vide No.VIG-84/2023/790, dt. 16/06/2023, the Department of Elementary Education is pleased to promote Shri **Riatwang Ngowa, PRT**, to the post of Trained Graduate teacher (TGT) against the vacant post of Shri Kusheshwar Prasad Yadav, TGT (retired) in Pay Matrix Level-7 pm plus other allowances as admissible as per rules from time to time with effect from 19/05/2023, until further order.

Terms & Condition of Promotion are as follows: -

1. The Promotion is purely temporary and may be reverted to **his** /her original post of Primary Teacher (PRT) after serving one (1) month notice in case any information furnished by the teacher proves to be false and if the teacher is found to have wilfully suppressed any material fact, **he** /she will be liable to be removed from service/ discharged from Provision and such other action may be taken by the Govt. as deem fit.
2. **His** / her continuation in the post is subject to satisfactory performance from the date of joining in the posted School.
3. After Promotion, **he** /she will be posted under the disposal of DDSE Khonsa, District Tirap, for new Posting place.
4. (I). The posting order shall be with immediate effect from the issue of this order, and stand relieved within **seven (7)** days from the present place of posting. Failing which **his** /her Promotion order shall automatically stand cancelled.
(II). No representation regarding change of place of posting will be entertained in any circumstances.
5. The other terms and condition of the appointment / promotion, which are not specified herein, shall be governed by the existing Government Rules and Orders in force issued from time to time
6. This issues with approval of the competent authority **Note No. # 60 dt. 29/07/2023.**


