ORDER

Dated Itanagar, the 25<sup>th</sup> March/08.

Mrs. Shampa Das, MA(History)B.Ed is hereby appointed temporarily to officiate as Senior Teacher (History) in the scale of pay of Rs.6500-200-10,500/-p.m. plus other allowances as admissible under rules from time to time she actually reports for duties. She is posted at Govt. H.S.School, Jeko, Lohit District, Arunachal Pradesh.

The appointment is made against newly created post vide order No.ED3/249/2006-07 dated 24/05/2007.

2. The appointee shall be on probation for a period of 2(two) years with effect from the date of joining. Her continuation in services beyond probation period of 2(two) years is subject to satisfactory performance during probation period.

3. **The appointment is subject to the following conditions :-**

- (a) The appointment is purely temporary and may be terminated with 1(one) month notice. If she wants to resign she may do so after giving 1(one) month notice or by surrendering 1(one) month's salary.
- (b) The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.
- (c) After joining duty she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- (d) She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- (e) The appointment is subject to the Police Verification and she will be dismissed from Govt. service if there is any adverse report against her.
- (f) On joining, the appointee shall have to serve for a minimum of 2(two) years at the place of posting.
- (g) Seniority of the appointee will be based strictly on merit list.
- (h) The appointment order shall be cancelled, if the appointee directly or indirectly campaign for change of posting or does not join within 10(ten) days from the date of issue of this order at posting place.

Other terms and conditions of service, which are not specified herein, shall be governed by the relevant rules and order in force from time to time.




