APPOINTMENT ORDER

Sri Rijjum Riba is hereby appointed as ICT-INSTRUCTOR(Secondary) on contract basis in the fixed pay of Rs.15,000 /-(Rupees fifteen thousand) only for the period of 10 months only with effect from the date of joining in the concerned posting place against centrally sponsored scheme of ISSE-Samagra Shiksha, created against Basar Block. The Selected candidate shall be appointed for a period of 10 month i.e. 1st June to 31st March 2024. However, they can be re-employed subject to the satisfactory to the duty and allocation of fund under ICT recurring cost in the subsequent year by MoE, Department of school Education and Literacy, Govt. of India.

Secondary School, Basar Bazar.

The appointment is made subject to the following terms and conditions:-

- 1) The engagement is a purely temporary basis and may be terminated from service anytime without assigning any causes/notice considering his/her performance of service.
- 2) The contractual appointment has no right to claim for regular appointment/regularization of the post after expiry of contractual period.
- 3) No earned leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
- 4) During contract service period he/she is not entitle for medical reimbursement, winter allowances (LTC), special compensatory allowance except fixed pay of Rs. 15,000/- (Rupees fifteen thousand) only per month.
- 5) The appointee has to report his/her duty at concerned posting place within 7(seven) days from the date of issue of this appointment order, failing which his/her appointment order will automatically be treated as canceled.
- 6) He/she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contact services.
- 7) No representation will be accepted for change of posting place.
- 8) The other terms and condition of service which are not specified here in shall be govern by the relevant rules and order in forced from time to time.
- 9) The appointee on contract basis has to sign an agreement for contractual appointment at the time of receiving his/her appointment order copy.
