Hr. Sec. School Telam, East Siang District Arunachal Pradesh.

The appointment is made vice Shri P.K. Bora, TGT, retired.

- The appointment is subject to the following conditions:-(2)
- The appointee shall be on probation for a period of 2(two) years w.e.f. the date of joining and their (i)
- The appointment is purely on temporary and may be terminated at any time by giving 1(one) month notice without assigning any reason thereof. If he / she wants to resign, he or she may do so (ii) after giving 1(one) month notice or by surrendering 1(one) month salary.
- The regularization of service shall be considered on completion of probationary period subject to (iii)
- satisfactory performance of duty in his/her initial place of posting. After joining duty, he / she will have to take an oath of allegiance of affirmation to the Constitution (iv)
- He / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- The appointment is Subject to the Police Verification and he / she will dismissed from government (\mathbf{v}) service if any adverse report is there with immediate effect. (vi)
- He / she shall remain in the place of posting for a minimum period of 3 (three) years from the date of joining. No representation / campaigning for the change of posting place shall be entertained before completion of 3(three) years of service in the initial place of posting.
