ORDER.

In pursuance of Govt. approval vide No 759 dated 16/11/05 Shri Dektu Bole, Class XII Passed is hereby appointed temporarily to officiate as AT(A) on compassionate ground in the scale of pay Rs. 4500-125-7000/- p.m. plus other allowances as admissible under rules from time to time with effect from the date he actually reports for duty to the DDSE, Along, West Siang District, Arunachal Pradesh.

2. The appointment is made on compassionate ground as per Govt. of India Ministry of Home Affairs order No.14014/20/90 Estt. (D) Dated 9/12/93. He is appointed against Shri Sandeep Hango, AT (A) expired.

Appointment is subject to the following conditions: -

- The appointment is on probation for a period of two years. During probationary period his services may be terminated at any time without any notice or assigning any reason. The continuation in the service will be subject to satisfactory performance of duty during probationary period.
- After joining duty he will have to take an oath of allegiance of affirmation to the constitution of India in the prescribed form.
- He will have to produce Medical fitness Certificate from an authorized Medical Officer at the time of joining.
- The appointment is subject to the Police Verification and he will be dismissed from Govt. service if any adverse report is there with immediate effect.
- The Educational qualification is temporarily relax for two years from date of joining. He is to produce Class XII passed certificate on or before expiry relaxation period.

Other terms and conditions of service, which are not specified herein, shall be governed by the relevant rules and order in force from time to time.
